Notice Concerning Change in Tenant <Sports Club Renaissance Hiroshima>

Frontier Real Estate Investment Corporation (the "Investment Corporation") hereby announces the decision of Mitsui Fudosan Frontier REIT Management Inc., the Investment Corporation's asset management company (the "Asset Management Company"), to conclude a new contract to set up a fixed-term land lease for business purposes with a new tenant (the "New Contract") as of today, in association with the termination of a fixed-term building lease contract with an existing tenant (the "Existing Contract") of Sports Club Renaissance Hiroshima owned by the Investment Corporation (the "Property"), as described below.

1. Background in Change of Tenant

Although the Property has been leased as a sports facility since the acquisition in April 2007, the Existing Contract's period will expire and the building has aged. Thus, multilateral considerations on the future management scenario have been made.

As a result, it has been judged that concluding a new contract with a new tenant and managing the Property as a land interest, without owning the building, will be the best option.

5. Outlook

Due to the demolition scheduled for the existing building, loss on retirement of the amount equivalent to the book value (assumed book value: ¥134 million) is expected for the period ending December 31, 2016. Furthermore, as indicated in "3. New Contract Detail, Special Agreement Concerning the Demolition of Existing Building" above, demolition of the existing building is scheduled to be conducted at the responsibility and cost of Kohnan.

6. Other
