Notice Concerning Change in Specified Related Corporation

Activia Properties Inc. ("API") announced a change in specified related corporation for TLC Activia Investment Management Inc. ("TAIM"), to which API entrusts its asset management. Details are as follows:

1. Reason for the change

The total sum paid by API for acquisition of trust beneficiary interests entrusting real estate, etc. (meaning real estate, real estate lease rights or land rights; the same applies hereinafter) ("trust beneficiary interest in real estate, etc.") to Classer LLC in the past three years from the last day of the fiscal period ended November 30, 2015 (from June 1, 2015 through November 30, 2015) was equivalent to 20% or more of the total sum paid or received by API for acquisition or transfer of real estate, etc. and trust beneficiary interests in real estates, etc. during the said period.

Thus Classer LLC falls under "specified related corporation" (corporation engaged in the transactions set forth in Article 29-3, Paragraph 3, Item 1 and Item 2 of the Order for Enforcement of the Financial Instruments and Exchange Act) as of December 1, 2015.
