Nomura Real Estate Holdings, Inc. announces that its major and largest shareholder and its other affiliated company will be changed on October 28, 2016.

1. Background to change

Nomura Real Estate Holdings, Inc. was reported that the resolution about dividends in kind as follows was passed in the shareholder meeting of Nomura Land and Building Co., Ltd., its major and largest shareholder and its other affiliated company on October 27, 2016.

Dividend property: 64,777,500 shares, all shares of Nomura Real Estate Holdings, Inc. which are owned by Nomura Land and Building Co., Ltd.
Allotment: Nomura Holdings, Inc., the 100% owning parent company of Nomura Land and Building Co., Ltd.

Along with this, Nomura Real Estate Holdings' major and largest shareholder and other affiliated company will be changed.

After this allocation of dividends in kind, Nomura Holdings, Inc. owns the shares of Nomura Real Estate Holdings, Inc. which are owned by Nomura Land and Building Co., Ltd. There is no change in the percentage of Nomura Holdings, Inc.'s voting rights including indirect ownership.
