Notice Concerning Scheduled Change of Directors and Key Employees, etc. at Succeeding Company following the Absorption-type Merger of the Asset Management Company and Relocation of Headquarters

Activia Properties Inc. ("API") announces that, in relation to the merger and acquisition between TLC Activia Investment Management Inc. ("TAIM"), to which API entrusts its asset management operations, and TLC Comforia Investment Management INC. ("TCI") as announced in "Notice Concerning Merger of TLC Activia Investment Management Inc., Asset Manager" on September 29, 2016 (the "Merger"), TCI, the succeeding company of the absorption-type merger, decided the below matters today.

In addition, TCI will change its trade name on the effective date of the Merger (scheduled as of April 1, 2017) to TLC REIT Management Inc.("TRM")
