Notice concerning Determination of the General Outline of the Unitholder Benefits Program

Nippon Healthcare Investment Corporation (the “Investment Corporation”) hereby announces that the Investment Corporation determined the general outline of the unitholder benefits program (the “Unitholder Benefit Program”) applicable for the Investment Corporation’s 8th fiscal period (the fiscal period ending April 2018) as follows.

The Unitholder Benefit Program provides the unitholders with an opportunity to experience the high quality management and services the operators of the healthcare facilities (the “Operators”) offer and to reach a better understanding about them.
