Notice of Joint Venture Agreement on Selling Vegetable Beverages in Hong Kong and Macau

NISSIN FOODS CO., LTD. (Executive Director and CEO: Kiyotaka Ando; hereinafter “NISSIN HK”), which is a subsidiary of NISSIN FOODS HOLDINGS CO., LTD. (President and Representative Director, CEO: Koki Ando; hereinafter “NISSIN HD”), and KAGOME CO., LTD. (President: Naoyuki Terada; hereinafter the “KAGOME”) have entered into an agreement regarding the formation of a joint venture (hereinafter “the JV”) to sell vegetable beverages in Hong Kong and Macau.

NISSIN HD announced its Medium-term Business Plan 2021 in May 2016. As a requirement for achieving global recognition as a global company, NISSIN HD is striving to achieve market capitalization of one trillion yen. As part of this effort, the company is actively pursuing business opportunities overseas. Since its establishment in 1984, NISSIN HK has been manufacturing and selling food products focusing mainly on high-value instant noodle products in Hong Kong and China.

KAGOME, under its slogan, “True to Nature, the Flavor of KAGOME,” has been dedicated to contributing to society by manufacturing products for a long, healthy life. KAGOME manufactures a wide variety of plant-based beverage brands, such as tomato and other types of vegetable juices, and has a large market share in the vegetable beverage industry in Japan. In 2014, KAGOME established KAGOME Hong Kong Co., Limited. (hereinafter “KAGOME HK”), a wholly-owned subsidiary of KAGOME. KAGOME HK has expanded its presence in the vegetable beverage market in Hong Kong through the import and sales of vegetable beverages manufactured by KAGOME in Japan.

Due to the increase of health-conscious consumers, the vegetable beverage market in Hong Kong and Macau is expected to grow even further. By utilizing NISSIN HK’s competitive advantage in terms of its sales force and diversified marketing channels, the JV aims to expand its sales and brand presence as the healthy and high-quality vegetable beverages containing only fruit and vegetables, which KAGOME is famous for. The company also plans to expand its market into the mainland China in the future.
