- Policy concerning lowering of trading unit On October 1, 2015, Meiji Holdings conducted a two-for-one stock split of common stock, resulting in the lowering of our trading unit. Evaluating stock market trends, we will examine if we would lower the trading unit with consideration of the following: company earnings, stock price, transitions in shareholder composition, and the cost and effect of lowering the trading unit.
