Notice Concerning Acquisition of DBJ Green Building Certification

Kenedix Retail REIT Corporation ("KRR") announced that it received DBJ Green Building Certification for two of its properties (Gourmet City Chiba-Chuo and Resora Obu Shopping Terrace) today.

1. Overview of DBJ Green Building Certification

The DBJ Green Building Certification Program is a program established by the Development Bank of Japan Inc. ("DBJ") in April 2011 to support real estate that meets environmental and social considerations. The program evaluates and certifies real estate with environmental and social considerations, taking into account each property's environmental features and measures taken for various stakeholders, such as disaster and community-conscious measures.

2. DBJ Green Building Certification Rank

The details of DBJ Green Building Certification that KRR received are as follows.

The following points were evaluated highly for the certification.

- (1) Disaster measures such as installation of emergency generator in collaboration with local administration and energy-saving measures such as installation of solar panels at Gourmet City Chiba-Chuo
- (2) Disaster measures such as building a framework for cooperation with tenants to provide goods in case of a disaster and contribution to local communities by providing spaces for disaster prevention event at Resona Obu Shopping Terrace



3. Future measures

KRR had received the certification for fourteen of its properties (Fululu Garden Yachiyo, MONA Shin-Urayasu, Passaggio Nishiarai, Daikanyama Address Dixsept, Unicus Ina, Unicus Yoshikawa, Yumemachi Narashinodai Mall, Kawamachi Yahagi Mall, Blumer Maitamon, Blumer HAT Kobe, Carino Esaka, Roseo Mito, Ashico Town Ashikaga and Sun Street Hamakita). With the two newly certified properties, KRR now owns sixteen DBJ Green Building Certified properties. KRR will continue to advance environmental and social consideration measures, including enlivening of local community through retail property management.
