Compared to year-ago sales including the Daimaru Urawa Parco store and the portion of the tenants around the Daimaru Kobe store transferred to the Real Estate Business, total sales of Daimaru Matsuzakaya Department Stores and the Department Store Business were up $0.1 \%$ and down $0.3 \%$ YoY, respectively, in May and up $3.0 \%$ and $2.7 \%$ YoY, respectively, in total for March to May.
