Kuraray Co., Ltd. (Head Office: Chiyoda-ku, Tokyo; President: Masaaki Ito, "Kuraray"), PTT Global Chemical Public Company Ltd.(Head office: Bangkok, Thailand; President & CEO: Supattanapong Punmeechaow, "PTTGC") and Sumitomo Corporation(Head office: Chuo-ku, Tokyo; President and Chief Executive Officer: Masayuki Hyodo, "Sumitomo") have reached a decision on the establishment of a joint venture company("Company") in Thailand for Butadiene derivatives.

With Hemaraj Eastern Industrial Estate (Map Ta Phut Complex), Rayong in Thailand, as the candidate of the production site, the Company-Kuraray GC Advanced Materials Co., Ltd.-is scheduled to manufacture and sell High Heat Resistant Polyamide-9T (PA9T) and Hydrogenated Styrenic Block Copolymers (HSBC).
