Nippon Building Fund, Inc. ("NBF") hereby provides notice of change in a specified associated corporation as follows:

Description

1. Events Leading up to the Change

As the total amount NBF paid to or received from, as considerations for its acquisitions or dispositions of real estate, etc. or trust beneficiary interest in real estate, etc., Mitsui Fudosan Residential Co., Ltd. that falls under the category of Interested Parties etc. of Nippon Building Fund Management, Ltd. ("NBFM"), to which NBF entrusts asset management services, during the past three years from the last day of the fiscal period ended December 31, 2017 (from July 1, 2017 to December 31, 2017), reached 20% or more of the sum total of the amount NBF paid to or received from Mitsui Fudosan Residential Co., Ltd. as considerations for its acquisitions or dispositions of real estate, etc. or trust beneficiary interest in real estate, etc. during the same period, Mitsui Fudosan Residential Co., Ltd. fell under the category of specified associated corporation. However, as it did not meet the concerned standard for the past three years from the last day of the fiscal period ended June 30, 2018 (from January 1, 2018 to June 30, 2018), Mitsui Fudosan Residential Co., Ltd. no longer falls under the category of specified associated corporation.
