## <u>Notice Regarding Determination of Terms and Conditions for the Issuance of Stock</u> <u>Compensation-Type Stock Options (Stock Acquisition Rights)</u>

Toray Industries, Inc. ("the Company", hereinafter) announces today that the Company has determined on the remaining terms and conditions for the issuance of Stock Acquisition Rights to its vice presidents, Members of the Board and directors decided at its meeting of the Board of Directors held on July 25, 2018.
