

New Management Structure and Changes to Board of Directors

Tokyo, **October 26**, **2018** – Fujitsu Limited has made the following new management organization as approved at a Board of Directors meeting today.

- Outline of Changes to Management Structure
 In order to achieve the initiatives to transform its growth strategy as soon as possible, with the goal of
 becoming a services-oriented company, Fujitsu will substantially change its management structure as below
 with the aim of speeding up decision-making and execution, as well as to clarify responsibility and authority.
 - A system of two Representative Directors (the president and one Assistant to the President), with two Executive Directors to resign.
 - Clarify business responsibility by limiting executive officers to current EVPs and above, thereby halving the number of executive officers.
 - Multiple business units to be consolidated within the Technology Solutions Sector, with the goal of simplifying the chain of command and creating synergies across previous units.
 - Enhance group governance by having the responsible executives at Fujitsu Limited concurrently serve as the
 presidents of some major subsidiaries, in order to accelerate the transformation of group structure from an
 overall optimization perspective.


