1. Outline and reason

However, in order to enhance opportunities of returning profits to shareholders, the Company will pay dividends of surplus twice a year as interim and year-end dividends, beginning from the fiscal year ending March 31, 2020. The Company stipulates in its Articles of Incorporation that it is able to pay interim dividends with a record date of September 30 of each year.
