Financial Highlights

Financial Highlights – Topics of FY 2019 Q1

- Net Sales decreased primarily due to decrease in Music Package sales, offset in part by increase in Anime & Visual Content Business. 29.0 billion yen (-10.1% YoY)
- 2. Operating Income is 0.3 billion yen (+136% YoY).
- 3. Net Income Attributable to Owners of Parent decreased primarily due to non-operating loss and extraordinary loss.-0.3 billion yen.
