Announcement of Partial Amendments to the Articles of Incorporation

TechnoPro Holdings (the "Company") has announced that, at the Meeting of the Board of Directors held on August 22, 2019, it resolved to propose partial amendments to its Articles of Incorporation (the "Articles of Incorporation") at its 14th Annual General Meeting of Shareholders scheduled to be held on September 27, 2019, as described below.

1. Reason for Amendments

- (1) Following the conversion of TECHNO BRAIN COMPANY LTD. into a wholly-owned subsidiary on February 28, 2019, the establishment of TechnoPro Innovation Partners LLC on March 15, 2019, to ensure agile decision making on investments as part of initiatives to promote globalization, and the expansion of product ranges at TechnoPro Smile, Inc., which is a special subsidiary that employs workers with disabilities, the Company proposes the amendment of Article 2 (Purposes) of the current Articles of Incorporation in order that business purposes provided in the Articles of Incorporation of the said entities be added to the respective items of Article 2, Paragraph 1 of the Company's Articles of Incorporation.
- (2) In addition, the Company proposes adjustments to item numbers of the Articles, accordingly.
