Notice Concerning Refinancing of Loans

Japan Rental Housing Investments Inc. (hereinafter referred to as the "Investment Corporation") announces that the Investment Corporation decided refinancing of the existing borrowings (hereinafter referred to as the "Refinancing") at a meeting of its Board of Directors held today.

I. The Refinancing

1. Borrowing of Fund

(1) Reason for the Borrowing

The Investment Corporation has decided to enter into new borrowings for purposes of refinancing the existing borrowings of totaling 2,000million yen, which are due for repayment on August 30, 2019. For details on the repayment, please refer to "2. Summary of the Existing Borrowings Subject to the Refinancing."

(2) Summary of Borrowings

The Investment Corporation has decided to enter into syndicated loan arrangements of JPY 2,000 million in total with 4 financial institutions with which the Investment Corporation currently has outstanding borrowings through a syndicated loan. MUFG Bank, Ltd. will be the arranger and agent.
