Notice concerning the Issuance of the Investment Corporation Bond (conditions decided)

Canadian Solar Infrastructure Fund, Inc. ("CSIF") hereby announced today its decision to issue the investment corporation bond ("Bond") following the resolution adopted at the board of directors' meeting held on October 23, 2019. The details are decided as follows.

2. Purpose of issuance

As CSIF have been seeking diversified financing sources, CSIF decided to issue the Bonds to utilize the current favorable market condition. The proceeds from the issuance will be utilized for repayment of the existing debt with the nearest maturity, acquisition of specified assets in the future, payment of maintenance cost (i.e. capital expenditures) and working capital.

- 3. Total Amount of proceeds, use of proceeds and timing of use
 - (1) Amount of proceeds (net) 1,097 million yen
 - (2) Use of proceeds and timing of use

820 million yen will be used for the repayment of borrowings due on February 2021 (planned repayment date: November 7, 2019). Please see the other press release issued today, "Notice concerning the Early Repayment of the Existing Borrowing".

The remaining proceeds will be utilized for acquisition of specified assets in the future, payment of maintenance cost (i.e. capital expenditure) and working capital.
