Notice regarding change in the shareholder incentive plan

At a meeting of the Board of Directors on March 27, 2020, the Company resolved to change its shareholder incentive plan as detailed below.

1. Reason for the changes to the shareholder incentive plan

The details of the changes to the shareholder incentive plan are outlined below.

After careful deliberation, the Company, determining to divert management resources to other profitable businesses to increase corporate value and better serve the interests of shareholders, decided to sell ProDrivers (chauffeur-driven car sharing service).

Moving forward, we will strive for further earnings growth to increase corporate value. We ask for the understanding of our stakeholders over this matter.

2. Changes to the shareholder incentive plan

(3) ProDrivers (chauffeur-driven car sharing service)

A chauffeur-driven car sharing service that makes transportation comfortable for business and everyday life

*The use of vans with seating capacity of eight to twelve people enables transportation of luggage as well.

- Tickets can be used to discount chauffer service fees by JPY3,000
- Requires reservations; as no vehicles may be available when trying to make same-day reservations, the Company recommends making reservations three days or so ahead of time
- · May not be used for chauffeur services overseas
- · May be used for pickup in the 23 wards of Tokyo, Musashino, and Mitaka
