Regarding the Fire Outbreak at Prologis Park Iwanuma 1 (As of May 5th)

Nippon Prologis REIT, Inc. ("NPR") has announced that the fire outbreak at Prologis Park Iwanuma 1 (the "Property"), which occurred on April 30th, has become under control of the fire authorities as of 4:00 PM yesterday although it has not completely settled down yet. At this moment, there are no reports of casualties as a result of the fire.

Looking at the current physical condition of the Property, the fire appears to have burned down the whole building of the Property. The cause of the fire and the extent of damages shall be investigated by the police and the fire authorities after the complete fire extinction.

The Property is covered by a fire and profit insurance, but it will likely take us reasonable amount of assessment time to determine the value of claim and its timing of payment.

We will promptly make further announcements when we identify the cause of the fire, the extent of damages and any potential material impact on NPR's operating result forecasts.
