Ms. Doi was not aware of the situation before the improper representation came to light. Ms. Doi fulfilled her responsibility after the incident came to light through participation in the Isetan Mitsukoshi Holdings board of directors' deliberation of measures to prevent similar incidents within the corporate group, including Isetan Mitsukoshi Holdings and MICARD, and her efforts to make all employees aware of the incident and strengthen employee education.
